

Grantmaking - In 2011, Potlatch Fund made a total of 99 grants for a total of \$268,085. The income for our 2011 grantmaking programs comes from a variety of sources: 1) revenue from our 2010 & 2011 fundraising galas, including the proceeds from our silent auction featuring Native art; 2) regrants from foundations that help support our 5 grantmaking programs.

Technical assistance - In 2011, Potlatch Fund provided 37 workshops and 21 conference presentations in Native and Tribal communities throughout the Pacific Northwest as well as regional and national conferences. At least 1300 people attended these learning opportunities. Topics covered in the workshops included: 1. Nonprofit Startup, 2. Journey to Successful Fundraising, 3. Financial Management for Nonprofits, 4. Board Governance and Strategic Planning, 5. Media Management
