She has held several corporate management positions, as well as Chief Development Officer at United Indians of All Tribes Foundation in Seattle; Development and Donor Education Coordinator at Changemakers Foundation in San Francisco; Executive Director at the NAYA Youth and Family Center in Portland; and Outreach Director at Western Water Alliance in Seattle. Susan is active within the philanthropic sector and has served on boards and committees locally, nationally and internationally.
