Grantmaking - 107 grants

The income for our grantmaking program comes from a variety of sources: 1) revenue from 2008 fundraising Gala, including a matching grant from W.K. Kellogg Foundations; 2) revenue from 2009 fundraising Gala; 3) three grants in 2009 that funded our grantmaking program.

We gave out \$190,000 in grants.

Fiscal sponsorship - 14 groups

In 2009, Potlatch Fund was able to offer fiscal sponsorship to 14 emerging Native led nonprofit organizations in the Pacific Northwest.

We offer this service to Native organizations who are in the process of seeking their tax-exempt status so that they may begin applying for grants. During this fiscal year, these 14 groups brought in \$178,534 in revenue.

Technical assistance - 34 trainings, workshops and conferences throughout the Pacific Northwest and elsewhere in the United States. Nearly 500 people attended these training opportunities.
